

# 1 Overall quality at a glance (i)

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for >=3, 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions <=5%

# 2 Ensemble composition and analysis (i)

This entry contains 20 models. Model 12 is the overall representative, medoid model (most similar to other models). The authors have identified model 1 as representative, based on the following criterion: *lowest energy*.

The following residues are included in the computation of the global validation metrics.

Ill-defined regions of proteins are excluded from the global statistics.

Ligands and non-protein polymers are included in the analysis.

The models can be grouped into 2 clusters and 1 single-model cluster was found.

# 3 Entry composition (i)

There is only 1 type of molecule in this entry. The entry contains 1520 atoms, of which 751 are hydrogens and 0 are deuteriums.

• Molecule 1 is a protein called Protein SHQ1 homolog.

# 4 Residue-property plots (i)



#### 7.1.5 Random Coil Index (RCI) plots (i)




















