## 1 Overall quality at a glance (i)

## 2 Entry composition (i)

There are 2 unique types of molecules in this entry. The entry contains 4579 atoms, of which 0 are hydrogens and 0 are deuteriums.

• Molecule 1 is a protein called CLIP-associating protein 1.

Xtriage's analysis on translational NCS is as follows: The largest off-origin peak in the Patterson function is 7.80% of the height of the origin peak. No significant pseudotranslation is detected.
