## 1 Overall quality at a glance (i)

The following experimental techniques were used to determine the structure:  $SOLUTION\ NMR$ 

The overall completeness of chemical shifts assignment was not calculated.

There are no overall percentile quality scores available for this entry.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for >=3, 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions <=5%

• Molecule 1 is a protein called PROTEIN PAB.



## 4 Residue-property plots (i)

These plots are provided for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

## 5 Refinement protocol and experimental data overview (i)

The models were refined using the following method: *DETAILS OF THE STRUCTURE DETER-MINATION AND ALL STRUCTURAL STATISTICS ARE GIVEN IN THE PAPER CITED ON THE JRNL RECORDS ABOVE. THE STRUCTURES ARE BASED ON 649 INTERPROTON DISTANCE CONSTRAINTS AND 26 DIHEDRAL CONSTRAINTS. NO HYDROGEN BOND CONSTRAINTS WERE USED.*.

Of the 200 calculated structures, 1 were deposited, based on the following criterion: *THE AV*-*ERAGE STRUCTURE PRESENTED IN THIS ENTRY IS BASED ON 20 STRUCTURES SE*-*LECTED ON THE BASIS OF CONSTRAINT VIOLATIONS.*
