1 Overall quality at a glance

X-RAY DIFFRACTION

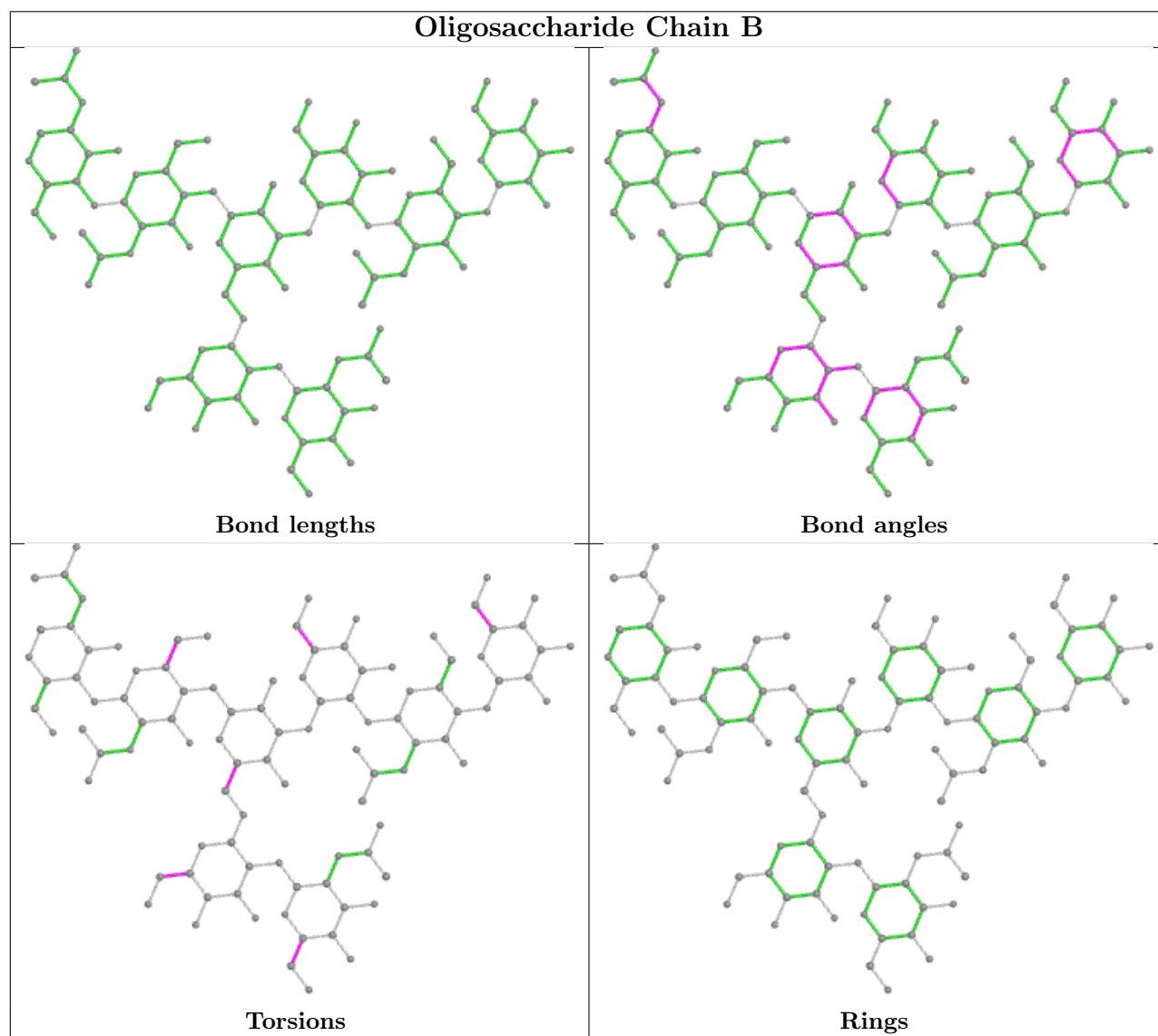

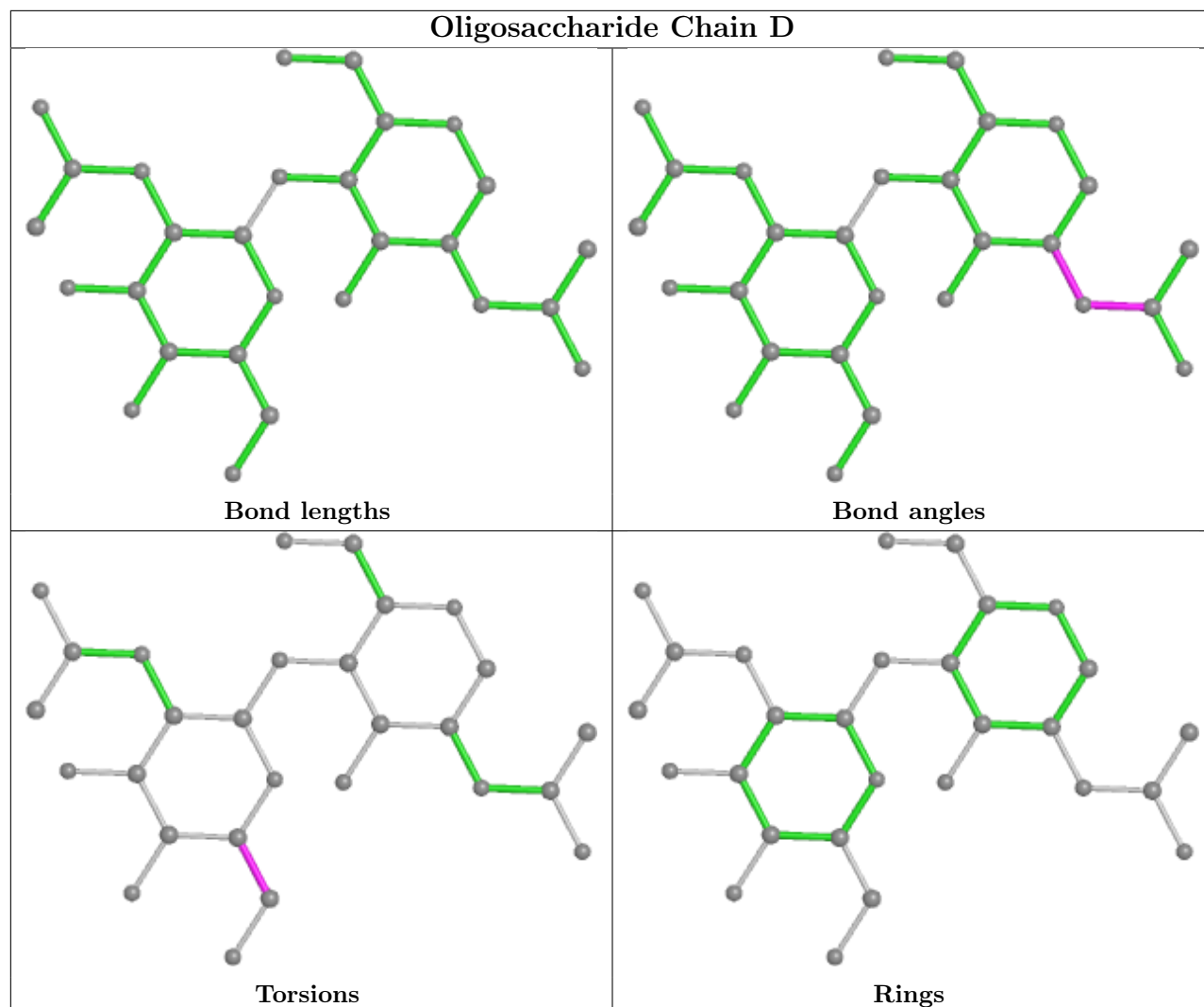
